Colorado Youth at Risk

Colorado Youth at Risk was founded in 1993 by a group of dedicated, passionate community members in response to the growing issue of youth violence and rising high school drop out rates in Denver. Since then, Colorado Youth at Risk has served more than 2,500 young people and trained more than 750 mentors, changing the lives of some of Denver's most marginalized youth. Colorado Youth at Risk provides quality training that is proven to make a powerful impact, not only in the lives of the youth it serves but the adult mentor as well.

Programs

Steps Ahead for Youth

Designed to support ninth grade students that are at risk for dropping out of high school, Steps Ahead is a year long community based mentoring program. Students participate in monthly structured workshops with a community of mentors and youth and one on one mentoring. The program is further unique because it includes a residential launch course retreat.

Touchstone Leadership

The Touchstone Leadership Program was created for 10th to 12th grade students who have already completed Steps Ahead. Touchstone focuses on bringing the youth back to the foundation skills they have learned while providing an environment to use these skills as they plan for the future.

The program also emphasizes leaderships skills, community service, grades, college preparation, graduation, interviewing skills, tutoring and career development projects.

Mission

Colorado Youth at Risk empowers teenage students to make life choices that positively impact their future through community based mentoring and intensive training.

Ninth grade is a crucial year for students – 64% of students who drop out leave before their sophomore year.

In Denver, only 38% of Latino boys and 51% of Latina girls graduated; only 47% of black males graduated and 59% of black females; 53% of white males graduated and 70% of white females.

Denver's graduation rates lag behind national averages. Nationwide, 58% of Latino students graduated high school, along with 53% of African American students, and 76% of white students.

Research demonstrates that youth who are in mentoring relationships show improved school attendance, have better attitudes towards school, and an increased chance of going to college.

Colorado has the second highest dropout rate in the nation.

Students in urban school districts like **Denver Public Schools** are **34% less likely to graduate than students in suburban districts.**

Students who do not graduate from high school cost taxpayers money through social programs such as unemployment, welfare, health care, and through costs associated with our criminal justice system. **One high school dropout can be expected to cost the public over \$200,000 over the course of his or her life.**

When Manual High school reopened in the Fall of 2007 Colorado Youth at Risk was eager to continue our relationship with the Manual community. We returned to Manual High school as an integral partner and provided the Steps Ahead for Youth program to 46 freshman students.

Colorado Youth at Risk launched 3 Steps Ahead for Youth programs during the same year for the first time ever. Since 1996 we have launched one or two programs per year and 2007 was the first time we launched three programs in one year, beginning the mentoring of 127 youth.

Due to our participation with the Youth Mentoring Collaborative, through the Department of Strategic partnerships with the City and County of Denver, we were able to transition our database. The web-based database designed by Civicore gives us better capabilities to track, report and manage volunteer, youth and donor information.

Colorado Youth at Risk increased the number of youth served in Touchstone by 89%.

Colorado Youth at Risk logged 21,147 hours, which amounts to an in-kind contribution of \$396,455. This is the equivalent of 10 full time employees.

Patti Bennett, co-founder of the organization and 16 year program director of Colorado Youth at Risk transitioned into the position of Executive Director. Hollen Ferrendelli stepped down as the Executive Director in December. Colorado Youth at Risk is grateful for everything Hollen provided while in this position.

When I decided to be a mentor almost 2 years ago never in my wildest imagination did I think that I would get so much out of it. My experiences with CYAR have not only made me realize how much one person can accomplish within a community, but how being a part of someone's life and watching them grow in maturity, responsibility, and confidence every day is so rewarding.

The two years I have spent with Erik have been some of the most rewarding years of my life. I've seen him turn into a young man that now realizes his future is as bright as he wants it to be. He not only believes in himself and pushes himself to succeed, but works on bringing up those around him so they can succeed too.

From the day Erik and I met, there was a bond. After the time we have spent together, he is as much a friend and a part of my family as he is someone that I mentor. The impact he has had on my life and the things I have learned from him are countless. When my wedding gets here in a few months not only will Erik be there, but he is doing me the honor of being a grooms man. I couldn't imagine such a special event without him. Thank you CYAR for giving me this opportunity and changing my life forever.

My name is Erik Aguirre and I am a 16 year old sophomore at Thomas Jefferson High school. When I started high school I started acting up and my grades were so low my GPA was down to a 1.2. I stopped caring about my future and anything else that came up.

At the beginning of the program they took us to the mountains which they said was where we were going to meet our mentors. While we were up there I was paired up with my mentor Scott Beach. Ever since that day Scott and I have been best friends. He has become a part of my family and we have each other's backs in any type of problem. I feel that thanks to the program and my mentor, my life has been better.

I set three goals for myself that I wanted to achieve. They were to get better grades, to have a better relationship with my parents, and to finish college. My grades shot up since I started the program. My GPA went from a 1.2 to a 3.1 and I made honor roll for their first time ever. Another goal that got accomplished was to have a better relationship with my parents. And the last goal that I have had on my mind is to finish college and get my name called out from that podium. I look back in the past and see that I have improved thanks to Steps Ahead. They have taught me how to deal with problems that I might have and to plan things in a helpful way. All I have to say is thanks Steps Ahead.



I have been Sanai's mentor, through Colorado Youth at Risk, for the past four years. Sanai has shown her relentless strength, courage and kindness through several difficult situations during this time, emerging even stronger. Sanai has shown me how it is possible to be a strong student academically along with being a faithful and energetic friend and inspiration for others. This balance is hard to come by, but it is something people always strive for.

When I first met Sanai, she had recently lost her father in a car accident. Due to her estranged relationship with him at the time of his death, Sanai had a lot of self-doubt, confusion, and hurt feelings. She was not looking for a mentor that would encourage her academically-because she knew that is not what she needed-but rather someone that could support her with friendship and support. I was emotionally overwhelmed with my choice of becoming a mentor, even though I wanted to do it, because I was unsure how I could relate to a teenager going through such a hard time. I also thought that a Caucasian girl from rural Wisconsin could have little impact on an inner-city teenager in Denver.

Little did I know that no matter where you come from, no matter your age, race or culture, a caring adult is ALL that teens need. I provided friendship

to Sanai in the past four years and some of my experiences to let her know that she's not alone in this journey. Who would have thought that often she would become the teacher and I the student, showing me the ways of loyalty, dedication, relentless energy and above all hope for the future.

Colorado Youth at Risk so opened my mind to working with teens that I chose to leave the software industry and pursue a career in teaching. I just received my Masters of Education degree and will be a high school Marketing teacher in the Fall, 2008.

I can look back almost 4 years ago and can honestly say, this program has prepared me for my future. When Nicole, my mentor, came in to my life, I wasn't so sure that it would be a good match. It took almost a year to truly get comfortable with each other, but it was worth it. Not only is she someone I can depend on, but she is like family to me. She was a stranger, yet she was there for me at one of the worst times in my life. She has never given up on me. She will always be cherished and I treasure her friendship. I've gained a lifelong friend and family. I now know how to love, trust, and truly be happy whole-heartedly. Without CYAR, I wouldn't have known how to deal with my tragedy, and though I'm still dealing with it, I no longer feel alone, and I can look into a brighter future.

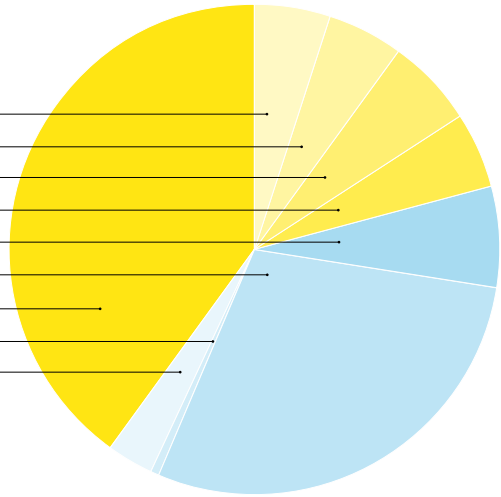

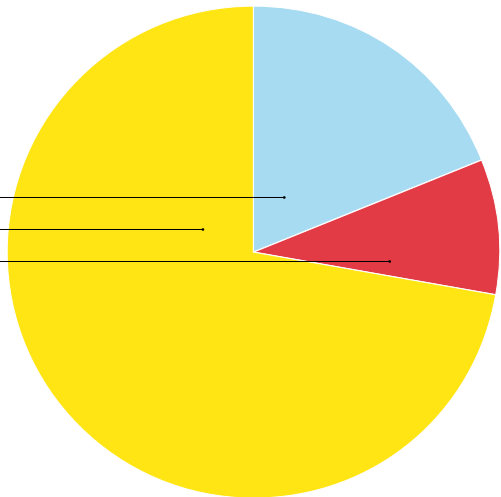
